HEREINAFTER REFERRED TO AS THE FIRST PARTY AND THE SECOND PARTY, hereinafter collectively referred to as **THE PARTIES**. Therefore, **THE PARTIES** make and sign this Cooperation Agreement, with the following terms and conditions:

FIRST CLAUSE PURPOSE

1. The purpose of this Cooperation Agreement is to synergize the potential of each party to achieve maximum results in the activities of Tri Dharma Perguruan Tinggi (Three Pillars of Higher Education).
2. The objective of this Agreement is to enhance the implementation of Tri Dharma Perguruan Tinggi programs, particularly in the areas of learning activities (Keynote Speaker), collaborative research activities (Joint Research and publication in accredited national journals), and community service activities (Community Service Group).

SECOND CLAUSE ACTIVITY IMPLEMENTATION

THE PARTIES agree that the Tri Dharma Perguruan Tinggi cooperation activities will be carried out in the following forms:

1. Exchange of academic resources and learning activities
2. Collaborative research activities (Joint Research)
3. Collaborative community service activities (Community Service Group)
4. Data acquisition, carried out jointly in accordance with agreed time and conditions.
5. Joint publication of research results in accredited journals.

THIRD CLAUSE OBLIGATIONS

THE PARTIES are obliged to:

1. Determine academic resources and learning activities jointly
2. Appoint lecturers and students in collaborative research activities (Joint Research)
3. Appoint lecturers and students in collaborative community service activities (Community Service Group)
4. Prepare activity reports and create research articles for publication in accredited journals.



FOURTH CLAUSE FINANCIAL RESOURCES

1. The financing arising from the implementation of this Cooperation will be determined according to the form of activities,
2. The amount of such financing will be determined based on the agreement of THE PARTIES in a proportional manner.

FIFTH CLAUSE DURATION AND TERMINATION

This Cooperation Agreement is valid for a period of 5 (five) years from the date of signing and can only be extended or terminated based on the mutual agreement of THE PARTIES made in writing.

SIXTH CLAUSE CLOSING

This Cooperation Agreement is made and signed on the day and date mentioned above in duplicate and both have the same legal force.

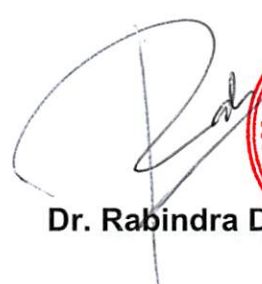
